4. 3PL/2020/0743/F Land East of Lynn Road, Lynn Road

Representatives from the Longhurst Group/Bidwell attended the meeting to inform the PC on the progress of this development and to answer any questions.

Copies of the latest plans were passed around to the Councillors and they went on to explain that there will be no changes made to the current footpath in that area, they have responded to the Highways concerns, the development will take 2 to 2.5 years to construct.

The Parish Council expressed their concerns as follows: -

76 houses (48 rental and remainder to be affordable ownership rent to buy) is far too large a development for a small village like Weeting.

The existing infrastructure - doctors, dentist, schools will not be able to support this amount of housing, they are struggling to cope with the existing resident's needs, there is currently a shortage of doctors and dentists in the area and local residents are finding it impossible to get appointments.

This development will add another 10% of houses in the village and the rule is no more than an additional 5% of housing can be built.

The properties are not carbon neutral.

- b) SAM 2 volunteer expenses following a discussion it was agreed to give Mr Norden £10.00 a month to cover his costs for petrol and admin costs.

8.2 Playing Field/Open Spaces

a) New Play Equipment – re 3PL/2020/0743/F

The Clerk had sent details of the play equipment that the Parish Council would like to have, however, the Clerk received the following reply from Planning: -

"Unfortunately, having looked through the details, the proposed equipment does not fit into the realms of Outdoor Sports provision. Therefore, we would not be able to secure a financial contribution from the above development towards this equipment/project. The applicants are prioritising children's play facilities on site in accordance with policy ENV04 of the Local Plan".

The Clerk has sent over prices for the benches to the football club, to date, there has been no reply back from them.

d) Replacement fence for the play area

The Clerk has applied for grants to cover the full cost from Mick George and Breckland – we should know by the end of September if we will be considered for the money from Mick George, we may hear earlier from Breckland.

e) Swift/Martin House

Cllr Eagle has informed the Clerk that none have been allocated so far.

f) Jubilee Orchard

Highways have given permission to plant trees on the land opposite The Row. Cllr Childerhouse asked that the Clerk contact Swaffham PC to ask if we can visit their orchard that was planted around 5-6 years ago to seek advice on the type of trees to plant and maintenance of the orchard, the Clerk will arrange this.

It was agreed to replace all three benches, the benches costs £477 + VAT each and are made of recycled plastic that requires no maintenance.
