### 7.1 Outstanding Highway Matters – to discuss any outstanding issues and to report any new issues

- a) Extension of 30 mph Speed Limit on Lynn Road to discuss recent email received regarding the length of the extension following a discussion it was agreed that the Clerk will contact Fabian Eagle to see if he can give us any support for this.
- b) Trod Funding from Breckland update on application to *Breckland Council Inspiring Communities* for £5,000 we should hear back from Breckland by the end of September 2024

While some have been away, we, the working committee have been in contact with various companies organizing workmen to come and fix things like broken windows and locks.

There are two main projects, the first being the fire alarms in the building, and the second is the outside cameras that have now been fitted on each of the corners of the hall, they are up and running and we also had an electrician to put in another double socket and now just waiting for the monitor to be fitted. We have, as Angie will tell you, various things arranged for this autumn, but there is always room for more, so if any of your groups have any ideas for a fun evening anything to make money to keep this hall going, then do please let us know, we will offer help to any group who has an idea.

With that in mind I have to say that this body is getting older, it is still capable of climbing ladders etc, when there is something arranged to bring money into the hall, for example, the last craft show-putting out 36 tables and over 70 chairs is okay, but because I have a group who meet most times on a Friday evening, they always stay and help me put them out, but after being there from 7am in the morning and making sure all crafters are happy through the day and Angie and her team feeding everyone with bacon rolls and hot dogs, when it came to putting everything back last time it was Karen, David, myself and Robbie dashing back and forth helping us and helping Angie to clean the kitchen, David will agree

with me when I say I had to stop him as it was too much work and the tables are very heavy after a long day, so I cancelled the craft show for this month as we decided without more help we could not do it again. I have another one booked for the 23<sup>rd</sup> November, but, again I am now saying as I am raising money for this hall I think some of the groups who use it should offer some help and all I am asking for is a few willing workers to come along about 2.30pm and help to put everything away, some of you are always there, Eva helps in the kitchen all day with Angie and, Daphne is always there running the raffle or anything else I need, Rita runs her own table to get money for her beloved cats and she needs every penny for the work she does, Karen usually runs the tombola and that is the only thing we get for our group, everything else goes to the hall, we usually get about £400 to £500, this is for everything in the kitchen, the money for hiring the tables and the raffle of which I go around and persuade the stall holders to give me something from their table for me to put on for the raffle, they always give willingly and we do get some great prizes. So, any of you that represent a group, perhaps you could go back and ask if any would like to volunteer, we do not want many people, 4 or 5 total would be great. Last Saturday, Mike rang me to say he had had a report from one of our neighbours that one of the windows had been smashed again, Karen and I met up with Mike and Sue and it started to pour down so my cardboard was not going to be any good to cover the hole. Mike rang Tim who came out straight away and put a good cover over it, I would like to say thank you so much to Tim, Mike and Sue, I contacted our Village Hall Chairman David and he got a glazier to come out the next day and we are now waiting for him to come and put the glass in.

I was hoping the cameras would show who had done the damage, I rang the camera firm and they sent a man out on Monday as we had not got the monitor fixed in place, but the camera on the corner did not pick anything up where the window was broken, he fitted a monitor that is now ready to watch, but again we have to arrange how many people have a code, so I have asked the firm to come back and fix another camera in the middle on the wall – field side, so as yet I do not have the total price, but I thank the Parish Council for their generous donation towards the CCTV on behalf of the halls committee.
