6.1 District Councillors Report

District Cllr R. Kybird – Breckland Council are in the process of carrying out a full review of the Local Plan and asked if the Clerk had received a Village Check list from them and has it been returned to them confirm that all was correct on the list, the Clerk confirm that she had, Cllr Kybird asked if he could have a copy of that document.

There has been a consultation on Shop front design and Cllr Kybird will forward this document on to the Cllrs.

Cllr S Chapman- Allen said that the garage is high on their radar. The Chair said that there are parking spaces that belong to Breckland that are being used by the Garage employees during the day, and this means that residents are unable to use those spaces, they are also using the car parking spaces outside the chip shop and surrounding areas etc. There are some signs that are on the side of the road that belong to the petrol garage that are on Highways land.

Cllr Chapman Allen pointed out that the date of the meeting for the Local Planning re-organisation will be sent to the Clerk the end of the next week four councillors and the clerk will be invited to attend this meeting which will be about the government's plans to increase house building in our area.

Cllr Tom Childerhouse asked if anything was happening with regard to Brandon Station - Cllr Chapman Allen said there was not.

7.1 Outstanding Highway Matters – to discuss any outstanding issues and to report any new issues.

- a) Street Signs that need replacing -Park View in Weeting and Brandon Road sign (location opposite Peppers Close Weeting) – Reported to Street Sign department - Peppers Close sign is being replaced but not Park View.
- b) Tree that needs cutting back on Breckland Land St Edmunds Road this has now been cut back. take of the agenda.

- d) Hockwold Road 30 mph post that has been hit by vehicle Highways have said that repair/replacement is not needed at this time but will continue to monitor the situation.
- e) Faded white lines on the Weeting bends Highways have sent the following reply "We have assessed this problem, and it does not meet our criteria for repair at this time. We will continue to monitor the problem as part of our routine inspections".

Since receiving this email, work has started on Brandon and Lynn Road to repaint the white lines and install new cat's eyes etc, this is part of the Local Safety Scheme.

However, it needs to be noted that we are now within nesting season, so most works are restricted".
