### 12. DISTRICT AND COUNTY COUNCILLORS REPORT

### 12.1 District Councillors Report

District Cllr Sam Chapman-Allen – Another busy 12 months for Breckland., we still have the lowest council tax in the county, our level of service still continues for things such as waste collection, but, there are still challenges such as fly tipping across the Breckland areas. Our community grants will continue for up to £5,000 for play equipment etc. The biggest challenge for Robert and myself over the next two years is the government reorganization for the future of Breckland DC and Norfolk CC which will see the disappearance of Breckland as it becomes part of a larger body, with regards to Breckland it will a single merger with the Borough of Kings Lynn. The next biggest challenge beyond that will be the Local Plan whereby our housing target is now 900 a year up from 600, some of you mayl be joining us on line next Tuesday  $20^{th}$  May for an update on the process of that housing allocation, and three weeks after that there will be face to face meetings at Breckland to discuss this matter.

District Cllr Robert Kybird – next year will be an election of a mayor for Norfolk and Suffolk only if Norfolk and Suffolk County Council agree with the concept.

### 12.2 County Councillors Report

County Cllr Fabian Eagle – said he found it so refreshing to see the engagement between the Church and the Parish Council at Weeting.

For the first time in his time (Cllr Eagles) time with Norfolk County Council there will be an increase in services from NCC, there is an extension of the grass cutting on the verges and they will also be cutting back of the shrubs on dangerous verges, there has been an extra hazard waste collection amnesty in the Spring and there will be extra spraying on the pavements in built up areas. Some anti flooding equipment will be purchased which Parish Councils will be able to use if needed. He wants to

buy Village Fete necessities such as traditional village fete games that will be made available to villages to use at their various functions to raise funds for their organizations.

Cllr Sue Nairn asked if there was any more thoughts regarding the installation for solar panels on forestry land – Cllr Eagle said that he has been made aware that there will need to be a change in the law for this to happen in which wind turbines could be installed in those areas.
