1. WELCOME

The Chair welcomed everyone to the meeting.

2. APOLOGIES OF ABSENCE

3. ACCEPT AND SIGN THE MINUTES

The minutes of the Annual Parish Council Meeting held on the 15th of May 2025 were accepted by all who were in attendance as a true record of that meeting, a copy of the minutes will be posted on the notice board and the Parish Council website.

6. DISTRICT AND COUNTY COUNCILLORS REPORT

- **6.1 District Councillors Report -** not at meeting apologies sent.
- **6.2** County Councillors Report not at meeting apologies sent.

7. MATTERS ARISING

- 7.1 Outstanding Highway Matters to discuss any outstanding issues and to report any new issues.
- a) St Edmunds Road Potholes/Trip Hazards by the Church Reply from Highways:" We have assessed this problem, and it does not meet our criteria for repair at this time. We will continue to monitor the problem as part of our routine inspections." Following a discussion, it was agreed that the Clerk will go back to Highways as the state of the path is a definite trip hazard.
- b) Missing Speed limit signs between Weeting and Brandon reported to Highways in May and they have now been put back into place.
- c) Sam 2 Pole that was removed by highways maintenance during the recent works on Lynn Road reported Highways in May 2025 and they are looking into this.
- d) Castle Close damaged manhole cover- reported to Highways in May fixed 17th June.
- e) Various locations in Weeting -Weeds on footpaths reported to Highways as we are receiving lots of complaints and we have received the following reply. "The weed treatment started on the 19th of May across the County, with recent weather (both wet and warm weather) has provided ideal growing conditions. I hope that the weed treatment that started on the 19th of May will soon show signs of weeds dying off, however I will make my team aware to identify areas where we can programme works to 'side out' and remove this type of issue across our sector".
- f) To Discuss any Highway matters that have arisen since the publication of the agenda.

The Junctions at Saxon Place and Hereward Way going out on to Lynn Road—the give way road markings on the road have faded and are no longer visible and the Give Way signposts are missing. Cllr Wilkins pointed out that Give Way road markings and/or signs are needed coming out of the petrol Garage on to Hereward Way and Saxon Place as, she has seen cars coming straight out without stopping or looking, the Chair said that those roads belong to Breckland so we will need to speak to them.

The B1106 signs on the road between Brandon Level Crossing and Lodge Road Methwold have been covered up at the junction of Peppers Close, this road was downgraded to a C road back in 2004 (approx.) it is thought that this road should remain a B road as the volume of traffic is far greater now

than ever, we need to explore why this road has been downgraded, and following a discussion it was agreed to ask the area Highway engineer to meet the Clerk and Cllrs to discuss the very high volume of traffic that uses this road, the Clerk will copy in County Cllr F. Eagle when she sends over the email to Highways.

Peppers High Hill – hedges need cutting back on safety grounds – signs are not visible - and the hedges are hitting the cars.

Approaching Peppers High Hill – there are confusing signs stating that the maximum speed limit is 20mph as well as a sign saying it is 10mph.

It was agreed that the Clerk should contact our MP to let him know our concerns.

7.2 Playing Field/Open Spaces/ Amenities

- a) Dog Walk shrubs need trimming back- work party was discussed at the last meeting in May Cllr T. Childerhouse said that it is not too bad at the moment.
- b) Parrotts Piece Water main sunken covers –inspected by Anglian Water and reported that no action required.
- c) ROSPA Report The annual inspection of the play equipment has been conducted and the final report circulated to the Councillors to discuss and agree on any repairs/maintenance needs to be done. It was agreed that there are no repairs needed at this time, although the picnic bench over the far side under the trees may need moving if we have the funds. Also, the Clerk will look at alternative companies to carry out the inspection for next year.
- d) To discuss any other Playing Field/Open Spaces matters that have arisen since the agenda was issue. Nothing more to discuss.
- 7.3 Breckland Local Plan Update regarding the Local development Scheme Cllrs T. Childerhouse, P. Nordan, M. Lister and M. Nairn attended the Round Table meeting at Dereham. The map showing land that could be possibly suitable for development was circulated to the Cllrs

Land at Lodge Farm is still earmarked for development, along with land on Fengate Drove in which 200 houses are planned.

The Cllrs observations for the land at some areas on Fengate Drove is that it is on the edge of a flood plain, there is also a risk of contamination on other parts of the land in this area.

On the Mill Farm Triangle –this has been specified as employment land which means it is unsuitable for housing, however, the planning officers have said that the top half would be suitable for an old peoples home and bottom end would be suitable for some sort of light industrial development. Types of housing suggested is a mixture of shared equity and privately owned properties.

7.4 Local Government Re-organisation

The NCC leader is pressing for a single unitary authority covering the whole of Norfolk, which means there will be no District Councils.

Breckland, Kings Lynn and West Norfolk and possibly North Norfolk have come up with suggestion that they merge, Broadland, Great Yarmouth and Norwich are also looking to merge.

It is down to the Government in the end to decide what is going to happen.

The Government want an elected mayor.

There is a meeting on the 21st of July which all are welcome to attend.

7.5 Weeting Parish Pencils – Update from the clerk on prices - £33.00 for thirty pencils It was agreed to order one hundred pencils with the wording "Thank you from Weeting Parish Council". These will be an alternative to the Weeting Lapel Pins that are given out as a reward for services to Weeting Village and residents.
